- 2. Kelly Erboe, CPA presented and reviewed with the Board the annual financial report for FY 2015-2016. Discussion had. No action taken.
- 3. Chief Kirk Wilson reported presenting the fire and ems monthly report and the ambulance revenue report for January through August, 2016; see written report.

## **OLD BUSINESS**

1. Chief Kirk Wilson presented a comparison of the ATS and Kurtz proposals for ambulance/fire personnel. The Board reviewed the current ATS contract terms. Chief recommended giving ATS the contractually required sixty (60) day termination notice. - 3. Chief Kirk Wilson presented the bid for acquisition of two (2) new 2017 Chevy Tahoes recommending acceptance of the Bud Weiser, Beloit WI bid of \$36,000.00 each; see attached. William Campbell moved approval of the Bud Weiser bid Second by Bryan Northrop. Discussion had. Motion carried.
